HOUSING AUTHORITY OF THE CITY OF COLLEGE PARK NOTICE OF PUBLIC HEARING FIVE YEAR PLAN, ANNUAL & CAPITAL FUND PLAN

The Housing Authority of The City of College Park (HACCP) is proposing to amend the Five-Year Plan, Annual and Capital Fund Plan. The HACCP will conduct a Public Hearing to obtain comments on its proposed Five Year Plan & Capital Fund Program Grant

(CFP). The Annual Plan and Five-Year Public Housing Agency (PHA) Plan describes the HACCP's mission and the long-term plan for achieving that mission over the subsequent one and five years. The Capital Fund Program (CFP) provides financial assistance in the form of grants to public housing agencies (PHAs) to carry out capital and management activities including those listed in Section 9(d)(1) of the United States Housing Act of 1937 (1937 Act).
